The risk of injury to my child from the activities involved in this program is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

- 1. In consideration of the acceptance of my child's application for entry in the above event, I hereby waive, release, and discharge any and all claims for damages for death, personal injury, or property damage which my child or I may have as a result of my participation. This release is intended to discharge the **Police Activities League** and its agents and volunteers from and against any and all liability arising out of or connected in any way with my child's participation in said event, even though liability may arise out of negligence or carelessness on the part of the person or entities mentioned above.
- 2. I understand that participants occasionally sustain mortal or serious personal injuries, and/or property damage, as a consequence thereof. Knowing the risks of a particular activity for which I have registered, I hereby agree to assume those risks and to release and hold harmless all of the person or entities mentioned above who (through negligence or carelessness) might otherwise be liable to me or my child (or my heirs or assigns) for damages.
- 3. It is further understood and agreed that this waiver, release, and assumption or risk is to be binding on my heirs, assigns, personal representatives, spouse, child and next of kin.
- 4. We will make good any loss or damage or cost the above entity may have to pay if any litigation arises on account of any claim make by said minor or by anyone on said minor's behalf.
- 5. I understand that participation in this event there is a risk of exposure to communicable disease. I hereby agree to assume that risk and to release and hold harmless all of the person or entities mentioned above who (through negligence or carelessness) might otherwise be liable to me or my child (or my heirs or assigns) for damages.
- 6. I, the parent/guardian, assert I have explained to my child/ward: the risks of the activity, his/her responsibilities for adhering to the rules and regulations, and that my child/ward understands this agreement.
